

**RESOLUTION OF THE CITY OF WOODBURY REAPPOINTING  
A GREEN TEAM ADVISORY COMMITTEE FOR 2014**

**WHEREAS**, the Mayor and Council of the City of Woodbury strives to save tax dollars, assure clean air and water, improve working and living environments to build a community that is sustainable economically, environmentally and socially; a community which would thrive well into the new century; and

**WHEREAS**, the Mayor and Council of the City of Woodbury wishes to build a model of government which benefits our residents now and far into the future with green community initiatives which are easy to replicate and affordable to implement; and

**WHEREAS**, in an attempt to focus attention on "Green" issues, Woodbury's Mayor and Council wishes to reappoint a Green Team Advisory Committee (GTA) for 2014; and

**WHEREAS**, the Mayor and Council of the City of Woodbury wants to continue the process of focusing on "Green" issues by reappointing the Green Team and by making application to Sustainable Jersey to achieve certification by the end of 2014.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the City of Woodbury that we do hereby reappoint a Green Team Advisory Committee consisting of five members who shall be residents or employees of the City of Woodbury, appointed annually, and whose term of appointment shall be through January 1, 2015.

**BE IT FURTHER RESOLVED**, by the Mayor and Council of the City of Woodbury that the Mission, Goals and Objectives for the GTA through January 1, 2015 are established as follows:

**Woodbury's Green Team Mission**

As the first City in the US to institute mandatory curb side pick-up of recyclables, the City of Woodbury will continue its dedication to "Go Green" by joining other New Jersey towns and become Sustainable Jersey Certified. In doing so, we as the Woodbury Green Team will be the catalysts to promote, encourage, initiate and support activities that generate reusing, recycling or reducing energy consumption in all areas of the City's operations and advocate for these activities throughout the City so all businesses and residents are inspired to participate.

**Woodbury Green Team's Goals for 2014**

1. Achieve Sustainable Jersey Certification by the end of 2014.
2. Update the Forestry Management Plan
3. Update the City's Tree Inventory
4. Pass the Tree Ordinance created in 2013
5. Continue to promote the Be In the Green Direct Install Program to all Woodbury businesses

**Objectives**


1. Continue to work on Sustainable Jersey certification points and implement programs/procedures into operational practices throughout the City.
2. Secure a contractor to update the Forestry Management Plan
3. To have Public Works update the current tree inventory
4. Put the Tree Ordinance created in 2013 before Mayor and Council within the first quarter of 2014.
5. Continue to work on the Be In the Green Direct Install program that was initiated in 2013.
