**RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING THE PURCHASE OF A TRASH TRUCK THROUGH THE
HOUSTON-GALVESTON AREA COUNCIL (H-GAC) COOPERATIVE PURCHASING
CONTRACT AND RESCINDING RESOLUTION NO. 18-63**

WHEREAS, on February 13, 2018, Woodbury City Council adopted Resolution #18-63, to purchase a Trash Truck through the National Joint Power Alliance (NJPA), but the purchase contract is no longer available; and

WHEREAS, pursuant to Resolution No. 17-158, the City of Woodbury is a member of the Houston-Galveston Area Council (H-GAC) Cooperative Purchasing System; and

WHEREAS, N.J.S.A. 52:34-6.2, as amended by P.L. 2011, c.139, authorizes the City to purchase goods or to contract for services through the use of a nationally-recognized and accepted cooperative purchasing system that has been developed utilizing a competitive bidding process by another contracting unit within the State of New Jersey, or within any other state, when available; and

WHEREAS, the nationally-recognized Houston-Galveston Area Council ("H-GAC") cooperative purchasing system, located in Houston, Texas, offers voluntary participation in its cooperative purchasing system for the purchase of goods and services from H-GAC vendors and purchases through H-GAC comply with the Local Public Contract Law Requirements; and

WHEREAS, the City of Woodbury wishes to purchase the following items through the H-GAC vendor, Grande Truck Center, PO Box 201210, San Antonio, TX 78220:
Western Star 4700SB Rear Loader Trash Truck

WHEREAS, the CFO has certified the availability of funds for such purchases, under Bond Ordinance 2266-17, budget account C-04-17-266-020 in the amount of \$119,289.00 and Bond Ordinance 2249-16, budget account C-04-16-249-020 in the amount of \$59,887.00 and budget account 8-01-26-305-220 in the amount of \$5,050.00;


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Woodbury, the Mayor concurring, that:

2. The Mayor, Administrator and/or CFO are hereby authorized to execute such documents as necessary to effectuate the purchase of the above-referenced Trash Truck through H-GAC for a total purchase price not-to-exceed \$184,226.00.


