**RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WOODBURY
AUTHORIZING THE PERSON-TO-PERSON TRANSFER FOR LIQUOR LICENSE
0822-44-006-008 FROM CLL LIQUORS, LLC (AKA SPIRITS WAREHOUSE) TO BKK
CORP**

WHEREAS, an application has been filed for a Person-to Person Transfer of Plenary Retail Distribution License Number 0822-44-006-008, heretofore issued to CLL Liquors, LLC for premises located at 429 South Evergreen Avenue; and

WHEREAS, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

WHEREAS, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions with Title 33; and

WHEREAS, the applicant has disclosed and the issuing authority reviewed the source of all funds used in the purchase of the license and the licensed business and all additional financing obtained in connection with the license business; and


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Woodbury does hereby approve, effective April 24, 2018 the transfer of the aforesaid Plenary Retail Distribution License to BKK Corp, and does hereby direct the City Clerk to endorse the license certificate to the new ownership as follows:
