RESOLUTION OF THE CITY OF WOODBURY AWARDING A CONTRACT TO RICCO CONSTRUCTION CORP. FOR THE DEMOLITION OF FOUR (4) STRUCTURES AT: 25 & 29 WEST CENTRE STREET 259 SOUTH BARBER AVENUE 319 EAST RED BANK AVENUE

WHEREAS, the City of Woodbury received public bids for the demolition of four (4) structures at: 25 & 29 West Centre Street; 259 South Barber Avenue and 319 East Red Bank Avenue in the City of Woodbury, Gloucester County, New Jersey, hereinafter the "Project"; and WHEREAS, a total of two (2) bids were received, as follows:

WHEREAS, the apparent low bidder, Brinks' bid was deficient in material respects and the bid is therefore non-responsive in that, specifically including, but not limited to, the bidder failed to complete the qualifications form listing five (5) projects similar to that specified in the specifications, failed to identify the dates or engineer in charge of the projects that were listed and failed to identify the municipalities within which two (2) of the jobs were performed; and

WHEREAS, such non-responsiveness is substantial and material in that specifically but not limited to its resulting in the Engineer's inability to adequately evaluate the bidder's ability to perform the contract or "responsibility" under the Local Public Contract Laws; and

WHEREAS, the Engineer, Solicitor and Administrator have recommended rejection of the Brinks' bid; and

WHEREAS, the second low bid of Ricco is compliant in all material, non-waivable respects; and

WHEREAS, the Chief Financial Officer has certified that funds are available.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Woodbury that:

1. The Mayor and/or Administrator are hereby authorized to execute a contract with Ricco Demolition Corp. for the demolition of four (4) structures at: 25 & 29 West Centre Street; 259 South Barber Avenue and 319 East Red Bank Avenue in the City of Woodbury, Gloucester County, New Jersey for the Base Bid and Alternates 1 & 2 amount of \$122,800 in accordance with the bid specifications, the bid of Ricco Demolition Corp. and the within Resolution acceptable to the City Solicitor and City Administrator.
