

ORDINANCE NO. 2291-18

**AN ORDINANCE OF THE CITY OF WOODBURY AMENDING
CHAPTER 89 "FIRE PREVENTION"
OF THE CODE OF THE CITY OF WOODBURY**

WHEREAS, the following amendments to Chapter 89 have been recommended to the Mayor and Council of the City of Woodbury to revise the permit fees to match those fees as set forth by the New Jersey State Uniform Fire Code; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Woodbury as follows:

1. Chapter 89. Fire Prevention Article I. Uniform Fire Safety Act of the Code of the City of Woodbury, is hereby amended and shall read in its entirety as follows:

§89-10. Permit fees.

The application fee for permits shall be as established by New Jersey State Uniform Fire Code N.J.A.C. 5:70-2.9(c):

- A. Type 1: \$54
- B. Type 2: \$214
- C. Type 3: \$427
- D. Type 4: \$641


BE IT FURTHER ORDAINED that all other sections of Chapter 89 shall remain in full force and effect.

BE IT FURTHER ORDAINED to the extent that any portion of the within Ordinance is declared in any way unenforceable same shall not affect the remaining provisions in this Ordinance.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon passage and publication as required by law.

THE FOREGOING was introduced by the City Council of the City of Woodbury at a regular meeting held on September 11, 2018. This Ordinance will be considered for adoption at final reading and public hearing to be held on September 25, 2018 at 7:30 p.m. or at such time as may be determined and announced, in City Hall, Council Chambers, 33 Delaware Street, Woodbury, New Jersey, at which time and place all persons interested will be given the opportunity to be heard concerning said Ordinance. During the time prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the City Clerk's Office to the members of the general public who may request same.


